#### ALEX ACRES RIFLE AND PISTOL RANGE, LLC RULES

- Only members may use the Rifle & Pistol Ranges. Members only will be allowed on the ranges & may NOT bring guests, children, animals, etc. Any member under the age of 18 MUST be accompanied by an adult member and that adult is SOLELY responsible for that child's safety.
- 2. Hearing and eye protection must be worn at all times.
- 3. Always treat every gun as if it was loaded.
- 4. No one is permitted beyond shooting benches until all guns are unloaded and in racks.
- 5. Safety lights **must** be turned on to let other members know someone is down range.
- 6. **Never** handle a firearm on the firing line when safety lights are on to indicate others are down range.
- 7. Pistols must have clips out, receivers open, and be facing down range.
- 8. Keep your finger off the trigger until ready to fire.
- 9. All rules **MUST** be obeyed, or you will be asked to leave.
- **10. NO** alcohol, illegal drugs or persons under the influence are permitted on the range. Also, **NO** smoking on the firing line. **IF CAUGHT WILL BE REMOVED FROM RANGE WITH NO FURTHER ACCESS ALLOWED, MEMBERSHIP DENIED AND NO REIMBURSEMENT.**
- 11. NO cross firing. Shoot only at targets directly in front of the bench from which you are firing.
- 12. NO rapid firing automatic weapons allowed.
- **13.** Shoot only at targets, not target frames, flags, or rocks. NO cans, bottles, or other portable targets are allowed to be used on the premises.
- **14.** Keep the action open and weapon unloaded until ready to shoot.
- **15.** Be sure of your target and what is beyond it before firing.
- **16.** All firearms and ammunition MUST be in safe and working order.
- **17.** Alex Acres Rifle & Pistol Range, LLC has the right to inspect all guns brought onto the range at any time.
- **18.** Alex Acres Rifle & Pistol Range, LLC reserves the right to cancel a membership at any time for failure to obey the rules or any misconduct by a member.
- **19.** Members are not allowed to walk or ride in the fields or woods at any time. You **MUST** always stay on the range. Members MUST always shoot from benches.
- **20.** All members must carry proof of membership at all times. All members have the right to request proof of membership or anyone on the range and to report any misconduct.
- 21. Do **NOT** move target boards.
- 22. No shooting of **ANY** wildlife at **ANY** time.
- 23. **NO** intentional destruction of range property will be tolerated!

- 24. Members must police their brass and clean up after themselves. Be considerate of the ejected brass from semi-automatic firearms to insure they are not interfering with other shooters.
- 25. Shooters may **NOT** use tracer bullets, exploding bullets, **NO** rapid firing weapons, and **NO** 50-caliber center fire.
- 26. When a shooter goes down range to targets, guns must be unloaded, magazines must be out of guns, chambers open on guns, and safety flags put up to alert other shooters that someone is down range and wear orange vest.

All persons using the rifle & pistol ranges do so at their own risk and peril. As such the Alex Acres Rifle & Pistol Range, LLC assumes no liability for the deliberate or accidental acts or negligence of those who use the facilities.

#### RELEASE AND HOLD HARMLESS AGREEMENT

I, the undersigned, agree to be responsible for my own safety while present on the lands of Alexander's Farm, LLC and Alex Acres Rifle and Pistol Range, LLC (whose members are Shirley S. Alexander, Deborah S. Alexander, James R. Alexander, and Samuel G. Alexander) (hereinafter collectively "Alexander") and agree to conduct myself as a safe and careful shooter. I agree to respect the rights of adjoining landowners and to acquaint myself with the boundary locations. The undersigned, being of legal age, in consideration of this license to enter upon the lands of Alexander, for myself, my heirs, executors, administrators, children and assigns, hereby release, acquit and forever discharge Alexander, Alexander's Farm, LLC, Alex Acres Rifle and Pistol Range, LLC, and any and all other related persons, firms and corporations of and from any and all suits, actions causes of action, claims or demands for damages, costs, loss of use, loss of services, loss of consortium, expenses, compensation, consequential damage, punitive damage, or any other thing whatsoever on account of, or in any way growing out of, or relating to, any and all known and unknown personal injuries and death and property damage resulting or to result from the undersigned's presence upon or engagement in sporting activities on said lands of Alexander.

I further agree to indemnify, defend and save Alexander, Alex Acres Rifle and Pistol Range, LLC, the members of Alexander's Farm, LLC and any and all other related persons, firms and corporations, harmless from any and all claims of any kind whatsoever including, but not limited to, claims for bodily injuries, economic losses and property damage which I may have or which I may cause to others or which others may have arising out of any injuries I may sustain or cause while present on said lands or engaged in use of the rifle and pistol range under this agreement.

I fully understand that use of the rifle and pistol range shooting can be a dangerous undertaking and acknowledge that this document constitutes sufficient warning thereof and especially the use of lethal weapons and unusual physical exertion which can cause serious injury or death, as well as to any dangerous conditions, risks and hazards which may physically exist upon the property. I hereby represent that I possess adequate training in the use of firearms and in the etiquette of their possession and use, and agree to abide by all applicable laws while exercising the license to enter granted to me by Alexander. I hereby acknowledge and assume that all risk, chance or hazard related to said activities or to my presence upon the lands and that the said injuries or damage may be or become permanent, progressive, greater, or more extensive than is now known, anticipated or expected. No promise or inducement which is not herein expressed has been made to me, and in executing this Release I do not rely upon any statement or representation made by any person, firm or corporation hereby released, or any agent, physician, doctor of any other person representing them or any of them, concerning the

nature, extent or duration of said damage or losses or the legal liability therefor or the risks related to use of the rifle and pistol range shooting.

I further represent that neither I, nor my heirs, executors, administrators, or assigns will cause to be filed any such action or claim as set forth above on behalf of any minor child or children which I may bring onto said lands for the purpose of engaging in any of the activities described herein.

I agree that this Release is not, and shall not be construed as, an admission of liability on the part of the persons, firms and corporations hereby released by whom liability is expressly denied. I further agree that this Release shall not be pleaded by me as a bar to any claim or suit, nor asserted as an admission of liability against the persons, firms and corporations hereby released.

I further state that I have read the foregoing Release and know the contents thereof, and I sign the same as my own free act.

### RANGE A USE OF SAFETY LIGHTS INSTRUCTIONS

- 1. BEFORE GOING DOWN RANGE TO CHECK TARGETS <u>TURN ON</u> FLASHING LIGHTS THAT ALERTS ALL OTHERS THAT A SHOOTER IS DOWN RANGE
- 2. WEAR ORANGE VEST WHEN DOWN RANGE
- 3. UPON RETURN TO FIRING LINE <u>TURN OFF</u> FLASHING LIGHTS SO ALL OTHER SHOOTERS KNOW IT'S ALL CLEAR AND SAFE TO RESUME FIRING

## **RANGE B: Pistol Range**

# RANGE B SAFETY LIGHTS INSTRUCTIONS:

- BEFORE GOING DOWN RANGE TO CHECK TARGETS <u>TURN ON</u> FLASHING LIGHTS THAT ALERTS OTHERS THAT A SHOOTER IS DOWN RANGE
- 2. WEAR ORANGE VEST WHEN ON RANGE AREA
