- 13: NO ONE is permitted downrange until all guests are aware of the call for a cold range, all firearms are unloaded and unmanned, safety light is on and if applicable the RSO/Range manager gives the all clear to go down range.
- 14: NO ONE is permitted to touch firearms after a cold session until all guests have returned and are accounted for, all guests agree to go hot, the safety light is switched off and if applicable, the RSO/Range Manager gives the HOT Range Command.
- 15: Never have a finger on the trigger unless the firearm is pointed downrange, the range is hot and you are ready to shoot.
- 16: No rapid fire is permitted unless under the supervision of an RSO or Certified Instructor.
- 17: On the pistol range, no movement during shooting is permitted unless under the supervision of an RSO or Certified Instructor.
- 18: On the pistol range, no shooting on the steel course is allowed without the supervision of an RSO or Certified Instructor.
- 19: No crossfire of targets is allowed. ONLY shoot your OWN target.
- 20: No Full Automatic weapons are allowed unless under the supervision of an RSO or a Certified Instructor. Permit showing proof of legality of the firearm may be required.
- 21: No tracer, incendiary or armor piercing rounds are permitted.
- 22: No shooting of anything other that targets. NO bottles, wildlife, structures or property is to be targeted. Intentional damage will result in fines and loss of Guest Privileges. Always be aware of what is beyond your target.
- 23: It is required to report **ANY** damage, accidental or otherwise.

### **AARPR GUEST RULES**

- 1: Only those with a Guest Privilege card, Guest Pass Waiver or Day Pass Waiver may be in the active range areas and participate in activities of any kind.
- 2: All guests must have their Guest Card or Waiver as well as a driver's license available upon request by any Range Manager, RSO or other Alex Acres Rifle & Pistol Range representative and **MUST** follow any command given by these persons.
- 3: Anyone without a current guest card or waiver must follow the instructions of the representative on how to alleviate the situation.
- 4: Anyone with an outdated/expired guest card/waiver must either immediately pay to renew their guest privileges, or leave and not return until they are ready to renew.
- 5: **Day** Passes may be issued only during scheduled times, when an RSO is present. Day passes are valid **ONLY** for the date & time of the provided Day Pass Waiver.
- 6: Single Day **Guest** Passes may be issued to a member in good standing, having been a member for at least 1 full year. They are to assume responsibility for the actions of their guest/guests. Guest passes are **ONLY** valid for the date of the provided Guest Pass Waiver.
- 7: ALL minors MUST be under direct ADULT supervision at ALL times.
- 8: Repeat offenders **WILL** be prosecuted & lose privileges permanently.
- 9: All shooters, regardless of possession Guest, day pass or guest day pass waiver, are guests of "AARPR" and are "<u>AT YOUR OWN RISK</u>", and are expected to always practice safety protocols & range etiquette.
- 10: Hearing and Eye protection must be worn at ALL times.
- 11: ALL firearms are to be treated as if loaded.
- 12: All Firearms must be pointed downrange at all times.

- 24: No ALCOHOL, ILLEGAL DRUGS, or persons UNDER THE INFLUENCE OF MEDICATIONS are permitted on the range. If caught they will be removed and lose all guest privileges permanently with no reimbursement of donations.
- 25: No trespassing in wooded areas, fields or pond area is allowed.
- 26: You are expected to clean up your area. Sweep and rake up all empty casings, shells or any other debris

A: Garbage including spent shotgun shells to be placed in garbage cans.

### **RELEASE & HOLD HARMLESS AGREEMENT**

I agree to respect the rights of adjoining landowners and to acquaint myself with the boundary locations. The undersigned, being of legal age, in consideration of this license to enter upon the lands of Alexander, for myself, my heirs, executors, administrators, children and assigns, as well as Stephen & Cameo Harrington, hereby release, acquit and forever discharge Alexander, Alexanders Farm, LLC, AARPR, LLC, Fods2025, LLC and Stephen & Cameo Harrington and any and all related persons including RSO's and Range Managers as well as firms and LLC's any and all law suits, actions causes of actions, claims or demands for damages, costs, loss of use, loss of services, loss of consortium, expenses, compensation, consequential damage, punitive damage, or any other thing whatsoever on account of, or in any way growing out of, or relating to any and all known and unknown personal injuries and death and property damage resulting or to result from the undersigned's presence upon or engagement in sporting and firearm activities on said lands of Alexander.

I further agree to indemnify, defend and save Alexander, AARPR, LLC, the members of Alexander's farm, LLC, Fods2025, LLC, Steve & Cameo Harrington, and any and all other related persons, firms and corporations and LLC's, harmless from any and all claims of any kind whatsoever including, but not limited to claims for bodily injuries, economic losses and property damage which I may have or which I may cause to others or which others may have arising out of any injuries I may sustain or cause while present on said lands or engaged in use of the rifle and pistol range under this agreement.

I fully understand that use of the rifle and pistol range, and use of any firearm can be a dangerous undertaking and acknowledge that this document constitutes sufficient warning thereof and especially the use of lethal weapons and unusual physical exertion which can cause serious injury or death, as well as to any dangerous conditions, risks and hazards which may physically exist upon the property. I hereby represent that I possess adequate training in the use of firearms and in the etiquette of their possession and use, and agree to abide by all applicable laws while exercising the license to enter granted to said activities or Alexander or Steve & Cameo Harrington. I hereby acknowledge and assume that all risk, chance or hazard related to said activities or to my presence upon the lands and that the said injuries or damage may be or become permanent, progressive, greater, or more extensive than is now known, anticipated or expected. No promise or inducement which is not herein expressed has been made to me, and in executing this release I don not rely upon any statement or representation made by any person, firm or corporation hereby released, or any agent, physician, doctor or any other person representing them or any of them, concerning the nature, extent or duration of said damage for

losses or the legal liability thereof or the risks related to use of the rifle and pistol range shooting.

I further represent that neither I, nor my heirs, executors, administrators or assigns will cause to be filed in any such action or claim as set forth above on behalf of any minor child or children which I may bring onto said lands for the purpose of engaging in any of the activities describe herein.

I agree that this release is not, and shall not be construed as an admission of liability on the part of the persons, firms, corporations hereby released by whom liability is expressly denied. I further agree that this release shall not be pleaded by me as a bar to any claim or suit, nor asserted as an admission of liability against the persons, firms, LLC's and corporations hereby released.

This release contains the entire agreement between the parties hereto, and the terms of this release are contractual and not a mere recital.

I enter this agreement in good faith, meaning I agree to both the written word, the meaning and the spirit of this release, and will not enter into it with any current or future intention of finding a loophole or wording in the document to circumvent the legality and spirit of this release.
